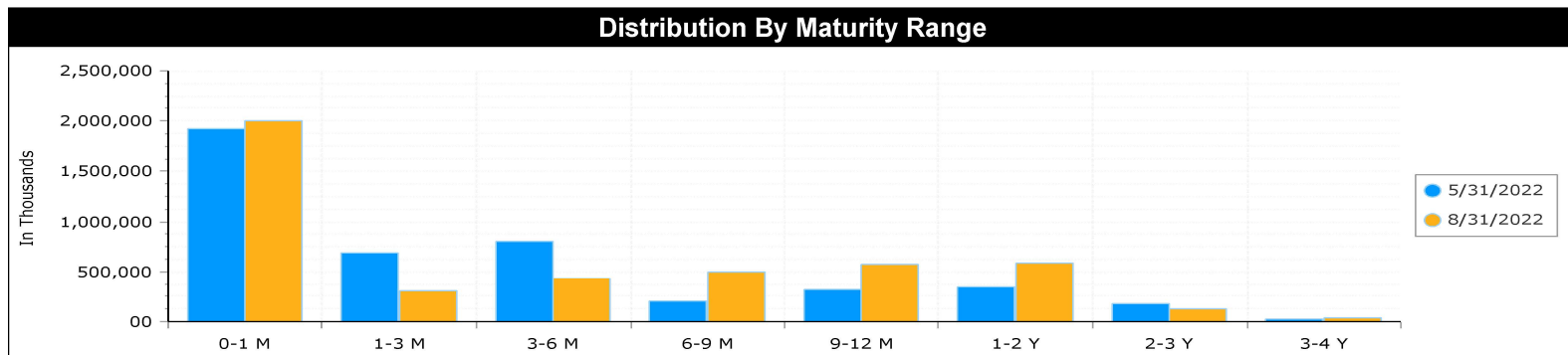
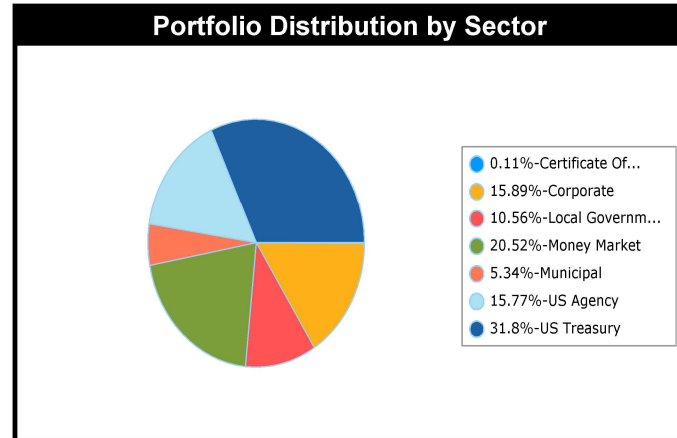

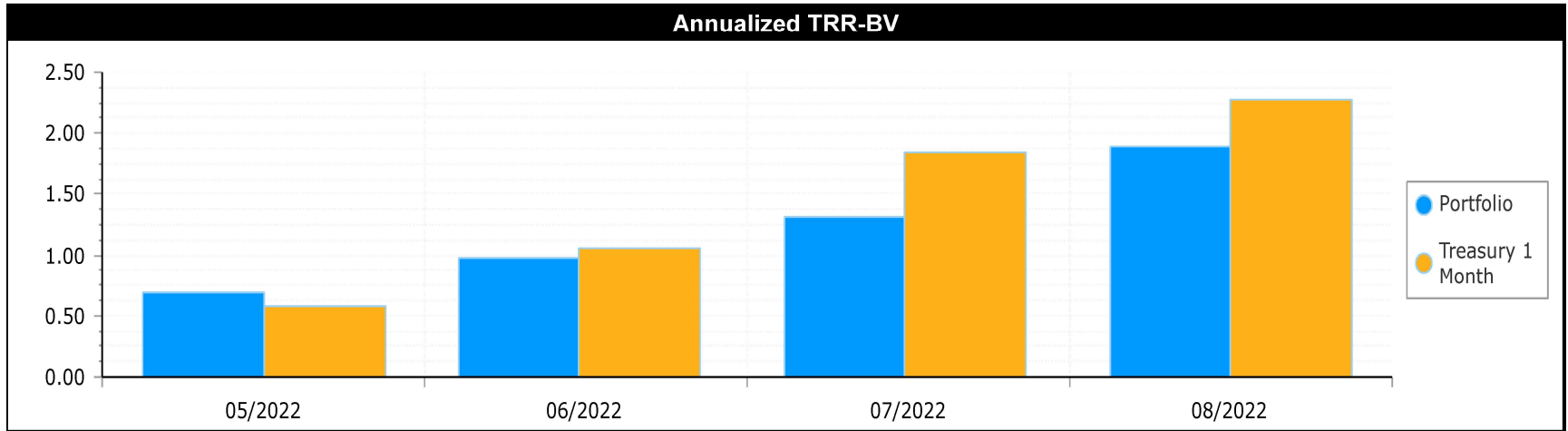

Quarterly Portfolio Compliance Check
Period Ending August 31, 2022

Hilltop Securities Asset Management, in providing a policy compliance check of the Harris County portfolio, has reviewed quarter end holdings for compliance with Texas state law, as well as adherence to the investment policy and intended fund strategy during the quarter ending August 31, 2022. Data used in preparing this review was obtained from Harris County finance officials.

Adherence to Policy:

Article V.

Investment Objectives

Section 5.01 General Objectives

- (1) *General objectives of safety, liquidity, marketability, diversification and yield are met.*
- ✓ The portfolio contains only U.S. Treasury issues, Federal agencies, municipal bonds, “Prime” commercial paper, AAA-rated money market funds and local government investment pools and secured bank deposits.
 - ✓ The portfolio appears to be sufficiently liquid with an average effective maturity of 121 days during the quarter, down from 146 days in the prior quarter.
 - ✓ The percentage in *full-faith-and-credit* Treasuries is approximately 32%, up from 30% in the prior quarter.
 - ✓ Commercial paper percentage is 15.8%, down from 18.7% in the prior quarter; *all issues are rated A1 P1 or better.*

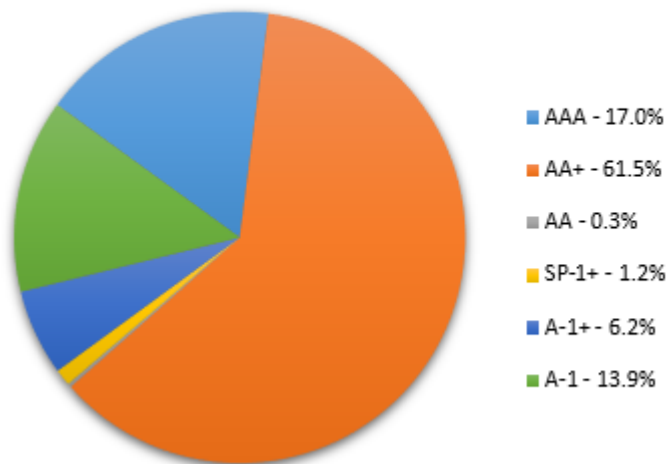
The August 31st average portfolio bond equivalent yield at cost of 2.02%, is up from 0.79% just three months earlier, and reflects solid current market yield for a short maturity portfolio with high credit quality.

- (2) *Safety of principal is the foremost objective.* County Designees shall seek first to ensure that capital losses are avoided, whether they are from securities defaults or erosion of market value.
- ✓ Safety of principal is reasonably assured through high quality investments and the short maturity structure of the portfolio. Treasury notes are backed by the full-faith-and-credit of the United States and are rated AA+ by S&P and AAA by Moody’s. Federal agencies (“instrumentalities”) including the Federal Home Loan Bank, the Federal Farm Credit Bank, the Federal National Mortgage Association (“Fannie Mae”) and the Federal National Mortgage Corporation (“Freddie Mac”) are also rated AA+ by S&P and AAA by Moody’s. As mentioned previously, the percentage of Treasury

holdings increased during the quarter, while the percentage of CP decreased. The result is an overall increase in portfolio credit quality.

- ✓ All municipal obligations in the portfolio are rated AA or better. Both money market funds are AAA-rated. **Toyota Motor Credit Corp (TMCC)** and **Toyota Credit Canada, Inc. (TCCI)** are all rated A1+/P1, the highest short-term rating categories of S&P and Moody's, while **BNP Paribus (BNPPNY)** is rated A1/P1/F1+, **Natixis NY (NATX)** and **Citigroup Global Markets (CGMI)** are rated A1/P1/F1, and **Mitsubishi UFJ Financial Group (MUFG)** is rated A1/P1.

☐ (4) *Investment Portfolio shall be structured to be sufficiently liquid to enable the County to meet all operating requirements which might be reasonably anticipated*

- ✓ As of the August 31, 2022 reporting date, approximately 31% of the overall portfolio is held in either demand accounts, investment pools or money market funds, while laddered maturities ensure additional liquidity. The 121-day effective WAM at the end of the period also indicates a highly liquid portfolio that *will adjust quickly* to Fed policy moves.

☐ (5) *The investment portfolio shall be designed with the objective of attaining a fair market yield throughout budgetary and economic cycles, taking into account investment risk constraints and liquidity needs. A fair market yield rate shall equal or exceed the available yield at the time of purchase on a U.S. Treasury security having a comparable maturity date.*

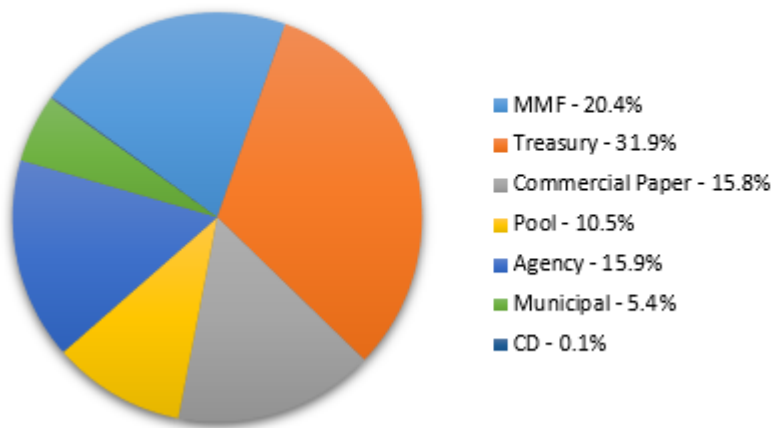
- ✓ The portfolio's weighted-average bond equivalent yield at cost May through August 2022 was 1.63%, below the average daily three-month Treasury bill yield of 2.08% during the period. *However, the Fed has aggressively raised rates to combat inflation meaning the benchmarks have accelerated beyond existing portfolios.* A period of underperformance is likely for the remainder of the year. At approximately four

months, the County's portfolio should turn over very quickly and the overall yield should move sharply higher between now and the next reporting period.

- (7) *No investments shall be made for the purpose of speculation, such as anticipating an appreciation of capital through changes in market interest rates.*
 - As of the August 31, 2022 reporting date, there is no indication that the County had entered into any speculative investments.

 - ✓ As of the reporting date, the County does not own over 10% of LOGIC, Texas CLASS or Lone Star Government. The County is reasonably well diversified by pool. *Confirmed*
- ☐ A Securities and Exchange Commission (SEC) registered, no load money market mutual fund which has a dollar weighted average stated maturity of 60 days or less. Furthermore, it must be rated not less than AAA or equivalent by at least one nationally recognized rating service and the County must be provided with a prospectus and other information required by the SEC Act of 1934 or the Investment Company Act of 1940. The County may not invest an amount that exceeds 10 percent of the total assets of any one fund.
 - ✓ The Fidelity Government Fund and Invesco Government Fund are both AAA-rated, SEC-registered, 60-day WAM money market funds. *Confirmed*

Section 5.04 Unauthorized Investment Instruments

The County may not invest *in any Collateralized Mortgage Obligation (CMO)*. In addition, the County may not invest in any Interest Only (IO) or Principal Only (PO) Mortgage-backed security or any obligation whose interest rate is determined by an index that adjusts opposite to the changes in a market index (inverse floater)

- ✓ There are no mortgage-backed securities, collateralized mortgage obligations or inverse floaters in the portfolio as of quarter end. *Confirmed*

Section 5.06 Maturity

- ❑ The weighted average maturity of the overall portfolio shall *not exceed three years*.
 - ✓ The effective weighted average maturity of the portfolio at quarter end was less than six months. *Confirmed*
- ❑ Maximum maturity of any investment held in debt service funds, the general concentration pool and custodial & fiduciary funds may not exceed three (3) years.
 - ✓ Maximum maturities in all of these funds are under stated policy limits. *Confirmed*
- ❑ Maximum maturity of any investment held in construction/capital project funds, the special revenue fund and flood control fund may not exceed five (5) years.
 - ✓ Maximum maturities in all of these funds are under stated policy limits. *Confirmed*
- ❑ Maximum maturity of any investment held in the proprietary & enterprise fund and public improvement contingency fund may not exceed six (6) years.
 - ✓ Maximum maturities in all of these funds are under stated policy limits. *Confirmed*
- ❑ Maximum maturity of any investment held in district clerk registry funds, county clerk registry funds and bond reserve funds may not exceed seven (7) years.
 - ✓ Maximum maturities in all of these funds are under stated policy limits. *Confirmed*
- ❑ Maximum maturity of any investment held in bond reserve funds may be invested to the final maturity of the bonds themselves.
 - ✓ Maturities in the bond reserve funds are appropriate.

Section 5.07 Diversification

- ❑ (1) *Portfolio investment maturities shall be staggered in a way that avoids undue concentration of assets in a specific maturity sector.*
 - ✓ The portfolio average maturity is still short from a historical perspective and there is more concentration on the short end than would *normally be considered desirable*. However, this strategy is highly advantageous in an environment when market yields are expected to rise, as there will be more spending capacity to employ in the future at higher yields.

❑ (4) Diversification Limits:

❑ Maturity. No more than 50% of the portfolio, excluding those investments held for construction/capital projects, special revenue, flood control, proprietary and enterprise, public improvement contingency, district clerk registry, county clerk registry, and bond reserves may be invested beyond three years, and the average maturity of the overall portfolio, with the previous exceptions, shall not exceed three years.

✓ The overall portfolio maturity averaged a conservative 171 days *during the quarter*.

❑ Risk Default. No more than 25% of the overall portfolio is invested in time deposits of a single user.

✓ There were no investments in time deposits at the end of the quarter.

❑ Marketability. At least 15% of the portfolio, excluding those investments held for future major capital expenditures, debt service payments, bond fund reserve accounts, and capitalized interest funds, shall be invested in overnight instruments or in marketable securities which can be sold to raise cash within one day's notice.

✓ Approximately 31% of the portfolio is held in fully liquid money market funds, investment pools and bank demand accounts.

Section 5.09 Risk Tolerance

❑ (1) All investment transactions will be conducted with approved banks, broker/dealers, money market funds, and investment pools as listed in Exhibit B of this policy.

✓ It appears as though all purchases made in the period were conducted with approved banks, dealers, funds, and pools.

In conclusion, all investments contained in the August 31, 2022 portfolio adhere to stated policy.
