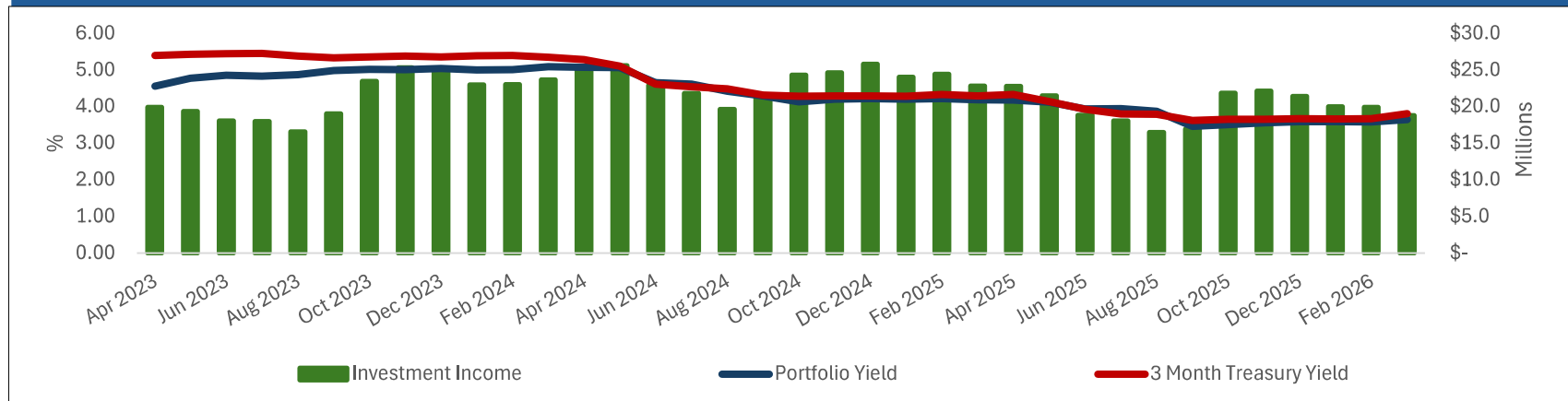

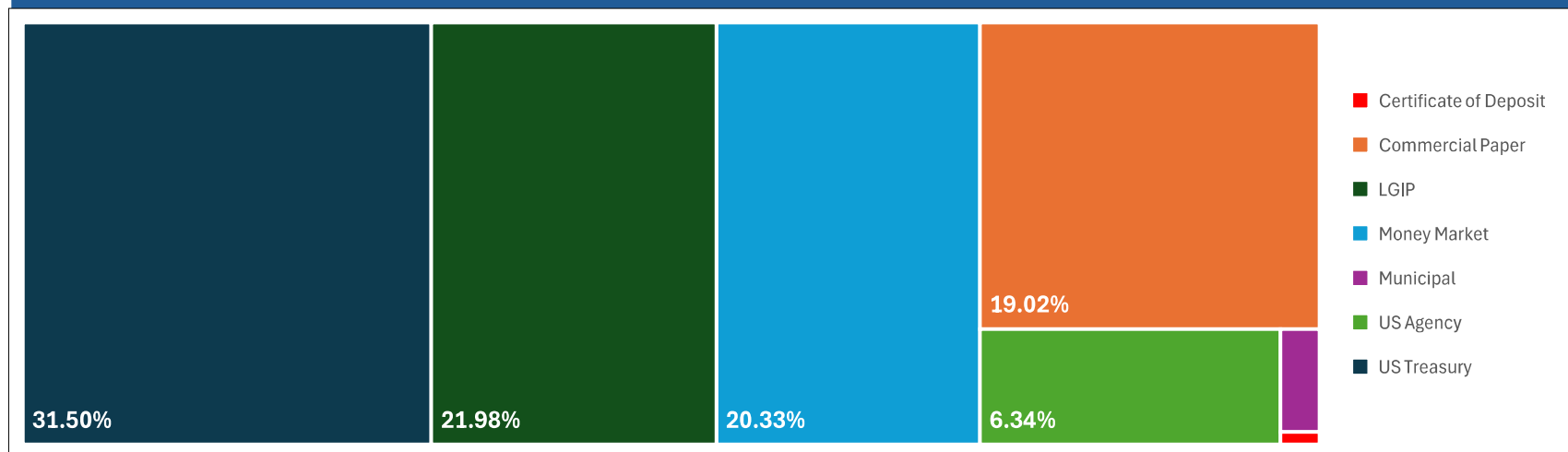
Investment Income

Investment Income vs. Market Rate

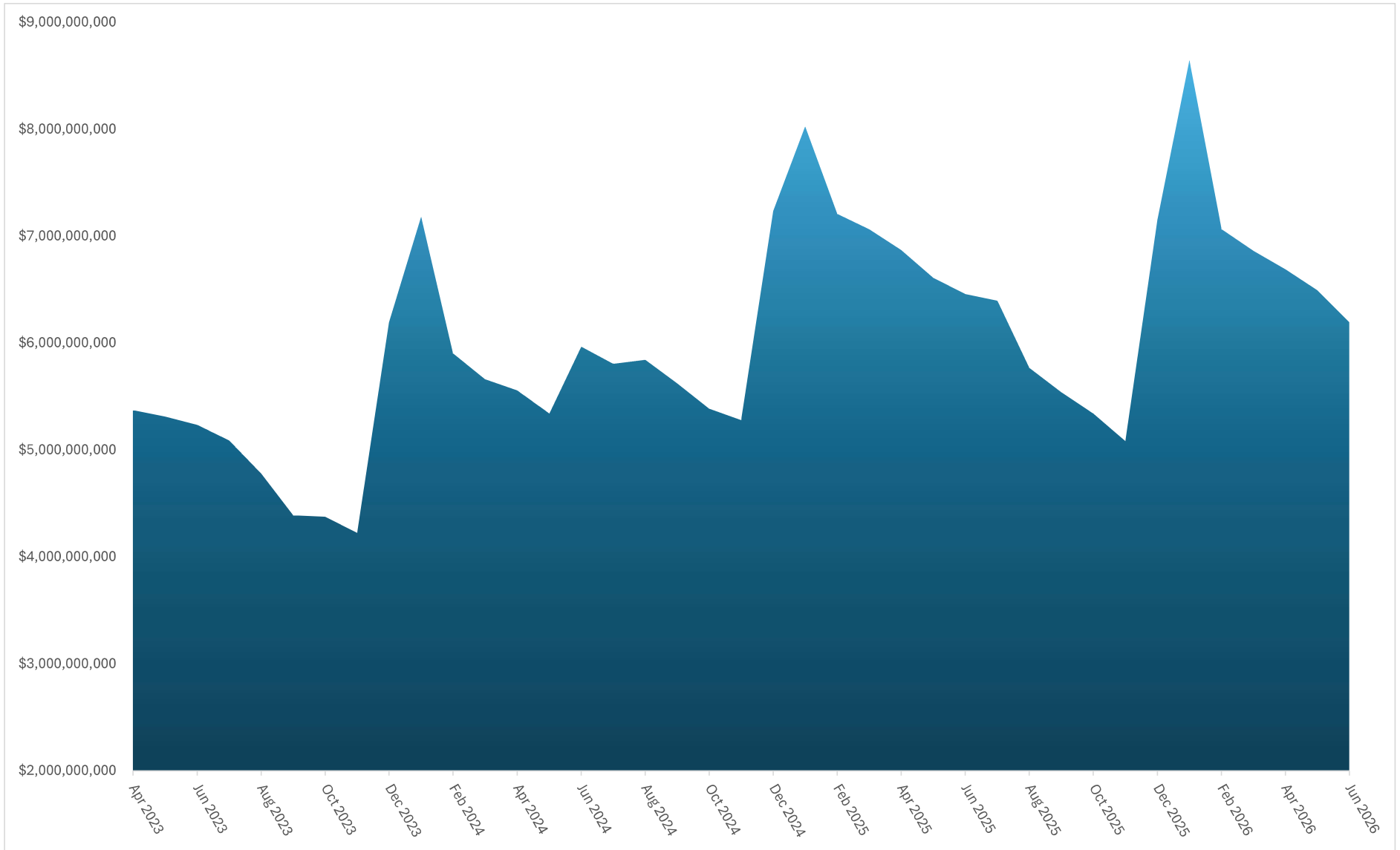


Portfolio Sector Allocation





Portfolio Balance History



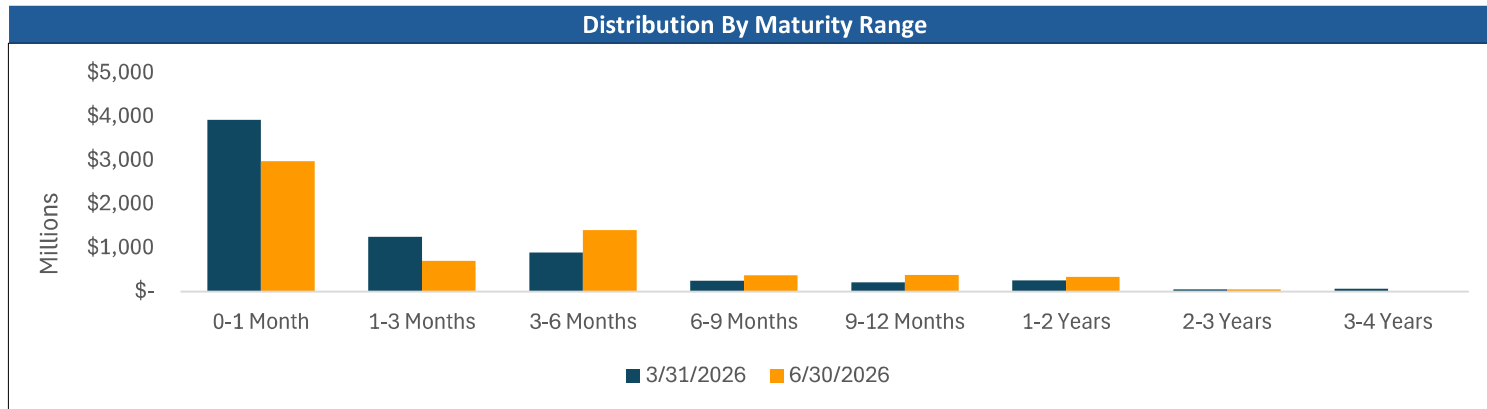

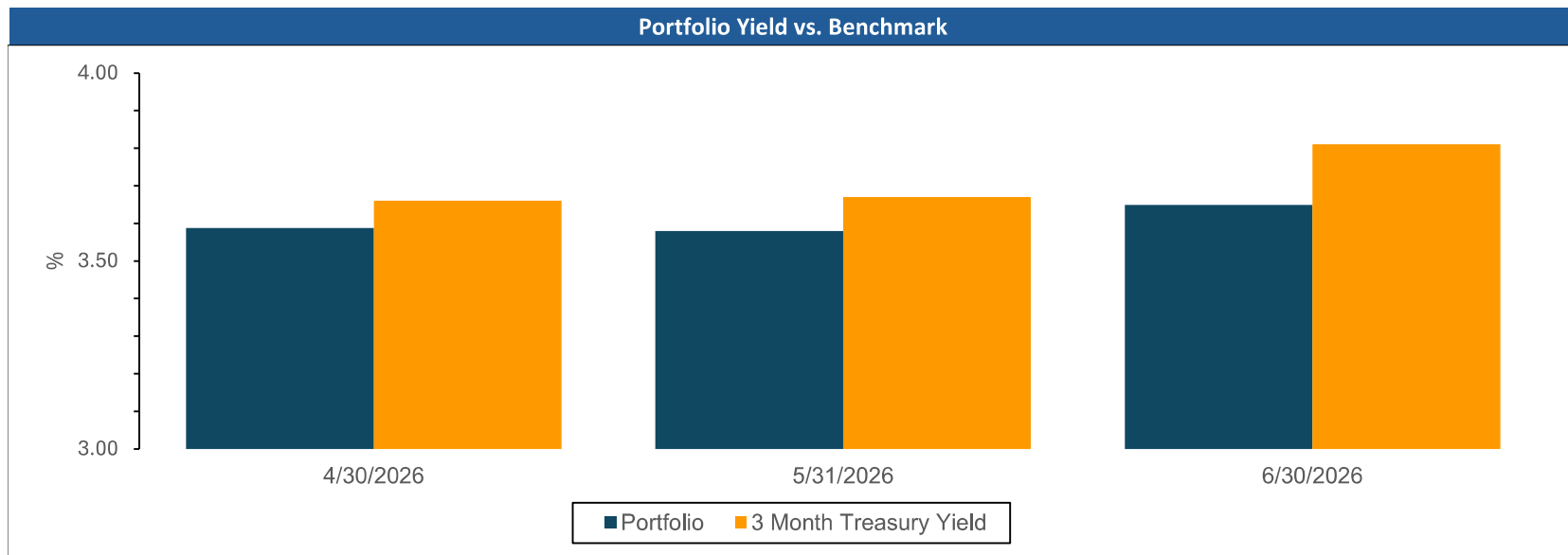
